Consequent upon the 2nd round of counselling for **upgradation / allotment** of seats, held from **26th July to 3rd August, 2017** for admission to 3 Year Polytechnic Diploma Courses-2017 in Polytechnic Colleges of Jammu & Kashmir State, the unfilled seats shall now be filled upon from amongst the candidates with the rank upto **6529** in the BOPEE office Jammu/Srinagar on **12th of August, 2017** on first come first basis considering the merit and preference of the candidates available in the BOPEE premises at relevant point of time.
