PUBLIC NOTICE NEET Undergraduate 2017

As aspiring candidates are already aware that Central Board of Secondary Education has invited application forms for NEET Undergraduate, 2017 to be conducted by Central Board of Secondary Education (CBSE) for admission to MBBS/BDS courses in India in medical/dental courses. The admission to all the seats of MBBS/BDS will be done through National Eligibility-cum-Entrance Test Undergraduate 2017. The application form should be deposited Online with effect from 31-01-2017 to 01-03-2017 with the last date of successful final transaction of fee till 01-03-2017 mid-night. All details of eligibility etc are available on the website of the CBSE viz www.cbse.nic.in. However, it is clarified that:-

- (i) The candidates have to fill up the form Online and should, therefore, carefully go through the instructions before finally filling in the form;
- (ii) The students from the State of Jammu and Kashmir alongwith students of **all** (please read) **some other States (like Andhra and Telangana)** are not eligible for 15% of All India quota seats as the State of J&K has opted out of the scheme since its inception. The details are contained in paragraph 3 of the eligibility and qualification part in chapter 3;
- (iii) Chapter 13 gives details about sending various requests/grievances to the CBSE;
- (iv) There is a provision of saving the number of application and once they are certain that the information given is correct, application can be submitted by them finally;
- (v) The CBSE has also put in the candidate friendly redressal system to ensure quick redressal of candidates grievances, which is given in the last part of chapter 13;
- (vi) They have also notified help line numbers for NEET UG 2017 which is as under:-

The candidates are, therefore, advised to contact the above helpline numbers and submit the grievances, if any.

It is further clarified that:-

- (i) while filling Online form at one stage the candidate has to indicate status of eligibility (for 15% All India Quota). It will generate self-declaration form. Since the State Government is not contributing to the 15% quota, therefore, the student of J&K State should click "No", because clicking "Yes" will make them ineligible for consideration for admission in the State Medical Colleges;
- (ii) there is no provision for modification of the data submitted once it is locked. However, at the time of counselling viz after declaration of the result, the matter can be taken up with the CBSC for a considerate view in the above case.

Since examination is being conducted by the CBSE, J&K BOPEE is not involved at this stage. In the process of counselling and the allotment of colleges shall be done by the BOPEE after the result of the candidates is declared. For facilitation of the candidates
