SUBJECT: - NEET PG -2017 verification of documents regarding.

Whereas, the candidates who had qualified NEET PG-2017 were advised to produce original certificates along with Photostat copies of the documents for verification in the Board offices at Srinagar / Jammu (as per their convenience) vide this public notice No. BOPEE/ Exam-14/ 2017 dated 27-01-2017 w.e.f. 02-02-2017 to 10-02-2017; and

Whereas, after expiry of the said date it has been observed that some candidates who had qualified the NEET PG-2017 failed to produce the documents / deposit the Photostat copies of the same; and

Whereas, such an act on the part of the candidates will lead them to disqualification from participating in further process of counselling / preferences and allotment of seats, if any, as per rules.

Now, therefore, the candidates who have failed to produce the original certificates / deposit their documents up to the last date i.e. 10-02-2017 in their own interest are advised to do so up to 16-02-2017 4:00 P.M failing which it shall be presumed that they are not interested to participate in the process of counselling anymore and their names shall not be included in the final lists as may emerge. The other terms and conditions shall, however, remain the same.


