## PUBLIC NOTICE

Subject:- Tentative seat matrix for MD/MS/PG Diploma/MDS - 2017

Whereas, the result of MDS/MD/MS/PG Diploma conducted by National Board of Examinations has been declared on 11-01-2017 & 13-01-2017 respectively; and

Whereas, allocation of seats/colleges is to be done by the concerned State Governments through the competent authorities as laid down in the rules; and

Whereas, it has been decided to notify the tentative seat matrix available for the year 2017 to enable the competing candidates to furnish their comments, if any.

Now, accordingly the tentative seat matrix for MDS/MD/MS/PG Diploma is hereby notified for general information of the competing candidates which shall be available on the website(s) of J&K BOPEE i.e. [www.jakbopee.org](http://www.jakbopee.org) / [www.jakbopee.net](http://www.jakbopee.net). Those who intend to furnish comments on the above seat matrix may do so, upto 01-02-2017. This seat matrix has been prepared, inter alia, considering the following:-

1. The seat matrix is provisional/tentative and prepared on the basis of applicable rules;
2. The candidates who have been declared to have qualified by National Board of Examinations (NBE) may furnish their comments, if they choose to do so, on the seat matrix, upto 01-02-2017 along with any documentary support which shall be examined by the Board. Such comments can be submitted in the office of the BOPEE at Jammu/Srinagar or scanned copy can be sent on the Board e.mail ID [helpdeskjakbopee@gmail.com](mailto:helpdeskjakbopee@gmail.com).

Following instructions are further issued:-

1. The rural service seats/difficult area service shall be filled up strictly in accordance with the rules on the subject including MCI regulation proviso 9(2)d read with the Hon'ble Supreme Court judgement in the case titled Dinesh Singh Chauhan V/s State of U.P. and ors.(The relevant extract of the MCI regulations and the Hon'ble Supreme Court judgement is available on the BOPEE

website and the candidates are advised to go through these in their own interest);

2. The certificate of belonging to rural service area/difficult area and having served in that area for the periods as specified in the rules including the MCI regulations viz 9(2)d shall be issued by the competent designated authority of the Health & Medical Education Department indicating all the details therein viz the difficult area served, period, eligibility as per rules and shall exclude the period spent on leave, absence, training etc. as stipulated in the relevant rules and regulations. The certificate signed by any unauthorized person shall in no case be entertained. Mere submission of such certificates shall not confer any right upon the candidates to seek admission in the courses, which shall purely be on the basis of eligibility/norms as laid down in the rules and regulations;
3. The percentage/percentile of qualifying marks shall be the same as notified by the NBE but these are minimum qualifying benchmarks and the seats shall be filled in accordance with the merit-cum-preference of the candidates. However, since the certificates have so far not been verified at any stage, therefore, the candidates are advised to keep the set of documents of all certificates viz qualification, State Subject, Date of Birth, Internship, passing of MBBS and the relevant category certificate handy alongwith two photographs, which shall be required by the candidates to be deposited in the BOPEEs office at Srinagar/Jammu when asked to do so. The documents should be self-attested by the candidates;
4. Since the reservation has to be provided to various categories like Scheduled Caste, Scheduled Tribe, Socially and Educationally Backward Classes as per the reservation applicable to the State, revised State provisional merit list would be required to be prepared after taking note of the reservations/documents produced by the candidates. The provisional State merit list, which shall be drawn, will take note of State reservation policy. However, certificates issued after the last date of submission of application forms viz 31.10.2016 for the NEET 2017 shall in no case be entertained;
5. The eligibility for CDP, SP, JKPM shall be strictly as per MCI regulations, viz qualifying marks shall be minimum 50%. Only such

certificates shall be entertained which are issued by the competent authority;

6. After completion of the verification of documents and preparation of provisional State merit list, the Board shall separately notify, seeking the preference for the subjects and the colleges from the competing candidates and the preference once exercised shall be final and no change shall be entertained subsequently. **The sole criteria for allotment of seats shall and shall be merit obtained and preference as may be indicated by the candidates, with application of relevant reservation rules on the subject, which shall be the guiding principle while working out modus operandi for counselling;** and
7. The candidates, in their own interest, are advised to remain in touch with the BOPEE website for updation of information.
