PUBLIC NOTICE

Subject:- NEET PG-2017, submission of documents by the candidates.

In continuation of the public notice dated 24-01-2017, vide which a tentative seat matrix for MD/MS/PG Diploma/MDS, along with certain instructions were notified, the following further instructions are hereby issued to the competing candidates who have appeared in the NEET 2017 examination, result whereof has been notified by the National Board of Examinations (NBE) on 11, 13 and 15-01-2017:-

- 1) The candidates who have appeared in the examination and belong to different categories having scored the minimum qualifying marks as notified by the NBE are hereby advised to fill in their biodata on format captioned "Check list" attached with this notice and also available in the BOPEE office, Srinagar/Jammu and also deposit self attested photostat copies of the following documents in the BOPEE office at Srinagar/Jammu with effect from 02-02-2017 to 10-02-2017 during the office hours only:-
 - i) Matriculation Certificate
 - ii) MBBS Degree certificate
 - iii) Internship completion certificate.
 - iv) MBBS Marks cards
 - v) NEET Result card (wherever applicable)
 - vi) State Subject Certificate
 - vii) MCI/ DCI/State Medical/ Dental Counsel Registration Certificate
 - viii) Category certificate (wherever applicable)
 - ix) Candidates passed MBBS Degree outside country enclose MCI clearance certificate.
 - x) NOC for seeking admission in PG/PG Diploma Courses from the competent authority in case of in-service candidates.
 - xi) MCI clearance certificate in respect of candidates who have passed MBBS from outside the Country.

- 2) The candidates belonging to reserved categories viz Scheduled Caste, Scheduled Tribe, RBA, ALC, OSC, who have qualified the examination, shall in addition to the above, also deposit their category certificate issued before the last date of submission of on-line application forms for NEET 2017 viz 30-10-2016. However, in case of candidates whose validity of the certificate had expired on the cut of date, but have renewed the same upto last date of submission of documents shall be eligible;
- 3) Those reserved category candidates belonging to RBA, ALC, OSC who have appeared in the NEET examination other than those who have secured minimum qualifying marks or more, as notified by the NBE, may also deposit their category certificates in the BOPEE office on similar lines along with other documents to meet shortfall, if sufficient candidates from these categories by order of merit, subject to minimum qualifying marks fixed by the NBE, are not available. In any case the reserved category candidates who have secured less than 40% qualifying marks/percentile shall not be considered;
- 4) The children of Defence Personnel, Para-military forces and State Police Personnel, who have appeared in the NEET-2017 shall, in addition to para 1 be required to deposit their relevant certificates to be issued by the competent authority on the prescribed proforma as per SRO 294 of 2005 and as notified by the BOPEE (copy of the proforma can be obtained from BOPEEs office at Srinagar/Jammu);
- 5) Similarly, the candidates possessing outstanding performance in sports (Sport Category) shall, in addition to para 1 be required to present their documents before the Secretary, Sports Council, notified earlier and the list submitted by Secretary, Sports Council to be received by the BOPEE office, shall only be entertained;
- 6) The candidates belonging to difficult areas/remote/rural service shall be required to submit the certificates with full details from the designated competent authority of the Health & Medical Education Department, indicating all the relevant details;
- 7) The candidates who have qualified the NEET 2017 shall be required to have completed the internship period on the date of submission of preference of seats/colleges for counseling and those not in possession of the same shall not be considered;

- 8) While depositing the documents, the candidates shall be required to produce the original documents also for verification by the BOPEE officials;
- 9) Sufficient time has been given to the candidates to avoid rush in the BOPEE office, therefore, candidates are advised to approach the BOPEE office at their convenience during the specified time frame viz 2-2-2017 to 10-2-2017 during the office hours and including the holidays;
- 10) After making necessary entries in the records/updating the records, BOPEE shall draw the State merit list out of the merit list provided by the NBE;
- 11) As the allotment of seats is to be made on the basis of merit-cum-preference, the BOPEE is separately seeking preference from the candidates for the seats and colleges, procedures and the time-frame for which shall be notified separately; and
