Whereas, the Central Council of Indian Medicine vide communication No.12-18/2016 NEET dated 13.02.2016 and Ministry of Ayush, Government of India letter No.R-13040/33/2016-HD (Tech) Part dated 25.01.2017 have intimated the J&K BOPEE that it has been decided to merge Ayush courses in National Eligibility National Test (NEET-2017) and;

Whereas, the J&K BOPEE vide its notification No.02-BOPEE of 2017 dated 14.2.2017 has decided accordingly not to conduct any separate test for BUMS/BAMS/BPT including Composite Regional Centre CRC courses i.e.BPT, DPO,DRT and DHLS;

Whereas, a consequence of the above, there shall be no Biology paper for CET-2017 to be conducted by the Board for 2017 ;

Now, therefore there shall be a single paper for CET-2017 for engineering courses only with three sections comprising of Physics, Chemistry and Mathematics as under:-

1. 60 questions from each subject with 1 mark to each question for Physics, Chemistry and Mathematics papers total 180 marks.
2. The duration of examination will be of three hours (single shift).
