### Subject: Filling up of MD/MS Management Seats of ASCOMS, Jammu through Joint Counselling by J&K BOPEE

Notification No. 013-BOPEE of 2017 Dated: 13-03-2017

Consequent upon MCI Notification Dated 08-03-2017 and communication No. F.No.11011/1/2015-MEP(Pt) dated 10<sup>th</sup> March, 2017 from Ministry of Health and Family Welfare, Government of India, all the MD/MS seats of ASCOMS and even those under management quota shall be filled up by the BOPEE through joint counselling.

Inview of the above following additional seats of ASCOMS in MD/MS have become available and shall be filled up accordingly:

- MD Anaesthesiology 2 seats;
- MD General Medicine 2 seats (1 NRI seat);
- MD Pathology 2 seats (1 NRI seat);
- MD Radiodiagnosis/Radiology 1 seat and
- MS General Surgery 2 seats

The above seats are governed by the following guidelines:

- ✓ 2 seats shall be allotted under open merit;
- ✓ 5 seats shall be allotted to eligible Hindu candidates of J&K in order of descending merit (as ASOMS has been accorded the status of minority educational institution) and
- ✓ 2 seats shall be allotted to NRI category candidates applying for the same as per their merit.

Additionally, in accordance with the directions and rules framed by the Statutory Monitoring Committee, the J&K Government under the Chairmanship of Justice (Rtd.) M. A. Jan the NRI candidates shall be considered out of the following:

- Category No. 1: Where applicant himself/herself is NRI and family originally belongs to J&K;
- Category No. 2: Children/wards of NRI who originally belong to State of J&K;

#### General: Candidates

1. should have applied under NEET & have qualified;
2. should also have deposited documents with the BOPEE in response to Notice No BOPEE/Exam-14/2017 Dated 21-01-2017 read with Notice No BOPEE/Exam-14/2017 Dated 22-02-2017;
3. in case not applied, can submit the documents etc., as asked for vide above notices, within four days i.e. upto 17<sup>th</sup> of March, 2017 05:00 P.M. but, such candidates shall be considered under

the NRI quota only and shall have no claim over other seats notified earlier or now;

4. In case of non availability of candidates for NRI quota, the seats shall be allotted to the existing candidates by merit cum online preferences considering the seats reserved for Hindus of J&K;
5. Annual Fee for Management quota seats shall be Rs. 9,00,000/= except for NRI quota seats for which annual fee shall be US \$ 21750 in terms of Government Order No. 221-HME of 2016 Dated 01-04-2016;
6. In case NRI seat is allotted to a non NRI candidate, in view of non availability of candidate(s); annual fee for such seat shall be the same as otherwise applicable to NRI candidates and
7. The eligibility of the candidates shall be the same as notified in earlier notifications and in conformity with the e-brochure.


