Subject: Provisional State Merit List of MD/MS/PG Diploma & MDS Courses- PG NEET 2017

PUBLIC NOTICE NO. 10-BOPEE of 2017

Dated: 17-03-2017

Whereas, Consequent upon the declaration of the NEET result the Provisional State Merit List (PSML) was notified vide notification no.08-BOPEE of 2017 dated 25-02-2017 vide which it was, interalia, observed that some candidates have not produced documents like;

- Qualifying Degree Certificate from the concerned authority;
- Registration certificate from MCI/DCI/SMC/DMC;
- Completion of internship certificate;
- NOC from concerned employer in respect of employees of Government Service and ;

Whereas, vide public notice No. 05-BOPEE of 2017 dated 28-2-2017 the candidates were advised to keep these certificates/documents ready and submit the same as soon as these become available and before the issuance of the last admission list of candidates and;

Whereas, the process of filling up of the Online Preference Form from the eligible candidates has commenced from 14-03-2017 and will conclude on 20-03-2017 and thereafter the board will take further action for preparation of the admission list on the basis of merit cum preference in accordance with the rules considering the time lines fixed for completion of the admission;

Whereas, many candidates who are "in service" of the Government who have qualified the NEET examination and figure in the Provisional State Merit List have not so far produced the NO Objection Certificate from the concerned employer and they are required to do the needful at an earliest so that while preparing the final admission list , they are considered in accordance with the rules. In case of failure to produce the NOC from the employer, they shall not be considered as the seats in the Medical Colleges can't be kept vacant and the process has to be completed in a time bound manner ;

Now, therefore such in-service candidates who have filled in their Online Preference Form or are likely to fill up the same by 20th March 2017 have not obtained the NOC from the employer are, in their own interest, advised to produce the NOC from the concerned employer/Government to pursue the said course in case they are selected by the Board for admission to the Medical Colleges, **latest by 31st March 2017** failing which it shall be presumed

that the candidates have not been allowed by the Govt./Employer to proceed for higher studies and they shall not be considered for allotment of seat in the Medical Colleges/Institutions for the year 2017. The candidates have also been allowed purely to participate in the counseling at their own risk and responsibility in accordance with the directions of the Hon'ble High Court and none of the eligible in service candidates has been debarred for applying on line for filling up of the Preference Forms

It is further notified and reiterated that participation of all the candidates in the process is provisional and subject to fulfillment of all conditions including the submission of NOC from the employer in accordance with the terms contained in the information brochure. Such of the inservice candidates who have not declared so while submitting the document/ biodate to the BOPEE shall, also in their own interest, be required to produce the NOC from the employer and if it is proved at any time that the candidates have concealed the facts with regard to being eligible / an in-service candidate his/her admission shall be cancelled abinito along with the penalty as may be deemed appropriate by the board including debarment of such candidates from future admissions in accordance with rule 12 of SRO 158 of 1995 as already notified in the information brochure.

Note:- The "Inservice" candidates who have submitted their NOC to the BOPEE are in their own interest advised to send a scanned copy of the NOC to the BOPEE for record & reference on the email: pgpreferences@gmail.com.

This issues without prejudice to the outcome of writ petition, if any, pending before any contempt Court of Law.
