Whereas, consequent upon Notification of increase in the seats in GMC-Srinagar and reference of Management Quota seats by ASCOMS, necessary modifications in the seat matrix were notified vide Notification No. 013-BOPEE of 2017 Dated: 13-03-2017 & Notification No. 014-BOPEE of 2017 Dated: 15-03-2017 and the Seat Matrix was also updated; and
