**Subject:- MD/MS/PG Diploma & MDS-2017 allotment of seats – Ineligible candidates in pursuance of SRO 8 of 2005 dated 18-01-2005 read with Information Brochure,2016 (16:XV).**

**Reference: Public Notice No. 009-BOPEE of 2017 dated 14-01-2017.**

**Notification No. 015-BOPEE of 2017 Dated: 19-03-2017**

Whereas, on the basis of complaints/representations received from some competing candidates for admission to MD/MS/PG Diploma & MDS Courses, 2017, a list of 26 candidates was notified vide Annexure “A” to Public Notice No. 009-BOPEE of 2017 dated 14-01-2017 against whom it was alleged that they are either pursuing Post Graduation Courses or have resigned after seeking admission from the concerned colleges and are not eligible under SRO 8 of 2005 read with the conditions contained in the Information Brochure; and

Whereas, the matter was also taken up with the concerned Medical Colleges as also the representations received from the candidates have been examined and considered. After due consideration of the mater it has been observed that:-

- (1).Following candidates who have joined the colleges and are either pursuing the PG Course or have resigned on or after 31<sup>st</sup> May, 2016 shall not be eligible for consideration for allotment of seats during 2017 in terms of SRO 8 of 2005 read with conditions contained in the Information Brochure notwithstanding that they have qualified the examinations:-
