Notification No. 17 -BOPEE of 2017 Dated: 21-03-2017

In continuation of Notification No. 15-BOPEE of 2017 dated 19-03-2017 read with Notification No. 16-BOPEE of 2017 dated 20-03-2017 vide which list of ineligible candidates in pursuance of SRO 8 of 2005 read with conditions contained in Information Brochure was notified for appearing in PG-2017 Course, the following candidate shall also be ineligible for admission to these Courses for the reasons indicated against her:-

01.	CD1771747	Prableen Kour	186	Pursuing PG Course in SKIMS, therefore, ineligible as per SRO 8 of 2005 during 2017.

The candidate shall, however, be entitled to make representation, if any, in support of her claim as per Notification No. 15-BOPEE of 2017 dated 19-03-2017 within three days i.e. upto 24-03-2017.

It is also reiterated that any other candidate admitted to the Medical Institutions during 2016 for MD/MS/PG Diploma and MDS Courses or who are pursuing Courses on the basis of earlier admissions shall not be eligible for allotment of a seat during 2017 and such cases shall be dealt with in similar manner as and when it is reported to the BOPEE and authenticated by it.

This issues without prejudice to the outcome of writ petition, if any, pending in any competent Court of law.
