Provisional State Merit List (PSML) of MD/MS/PG Diploma & MDS Courses - PG NEET 2017 - eligibility under Rural Service Quota -Examination/consideration of representations made and rejection of claim thereof.

Notification No. 028-BOPEE of 2017 Dated 09 -04-2017

Whereas, Dr. Faroz Ahmad Khan, Testing ID CD1779838, who was declared ineligible vide Notification No. 025-BOPEE of 2017 dated 04-04-2017 under Rural Service Quota of 10% for admission to MD/MS/PG Diploma and MDS Courses, made a representation requesting for re-considering the decision on the grounds that he is travelling 50 Kms from Srinagar (home place) to his place of posting and also that he is travelling more than 20 Kms within his jurisdiction; and

Whereas, a representation has also been received against Dr. Neeru Pangotra, Testing ID a candidate under MDS, who was declared eligible under Rural Service vide Notification No. 026-BOPEE of 2017 dated 07-04-2017. It has been stated in the representation that Thail area where the candidate has served is less than 11 Kms from the municipal limits and that she had appeared under SC quota in NEET 2017 examination; and

Whereas, the matter has been examined and considered. In terms of Rule 15(f) reproduced below:-

"15(f). Open merit category candidates other than those selected under item (i) above who have served for a minimum period of 5 years in Rural Areas.

Explanation: The rural service means service rendered in the areas at least 20 Kms away from municipal limits from the shortest possible route."

The above rule does not in any manner reflect distance from place of residence. Otherwise, also an employee is required to stay at his headquarters and not leave the station. The Deputy Commissioner, Budgam, has certified that the distance from Khansahib Municipal limit to PHC, Hardpanzoo is less than 20 Kms and, therefore, Dr. Faroz Ahmad Khan is not eligible for Rural Service Quota and the representation merits rejection; and

Whereas, the representation against Dr. Neeru Pangotra is under examination and a decision shall be taken in accordance with the rules and notified accordingly.

Now, therefore, it is hereby notified that:-

- the representation made by Dr. Faroz Ahmad Khan against having been declared ineligible under "Rural Service Quota" vide Notification No. 025-BOPEE of 2017 dated 04-04-4017 has been considered and found without any merit and is hereby rejected;
- 2) representation made against Dr. Neeru Pangotra is under examination and her eligibility under "Rural Service Quota" shall be subject to the outcome of the representation, which shall be notified at due course of time.

This issues without prejudice to the outcome of writ petition pending, if any, before any competent Court of law.
