- I. The candidates bearing Entrance Test Ranks given below are called for counselling for admission to MD/MS/PG Diploma Course as per the following schedule:

2	19-05-2016	<b>0001 to 0380</b> All those eligible OM/Category candidates in the Rank Range of 1-300, who have got admission in their allotted discipline/institution in the first & second round of counselling but are interested in upgradation/relocation, CNA candidates, and those candidates who have missed 1 <sup>st</sup> & 2 <sup>nd</sup> round of counselling/admission and the remaining candidates falling in the Rank range of <b>0301 to 0380</b>

### Important information:

- **Counselling Venue:** J&K Board of Professional Entrance Examinations, 4th Floor, South Block, Bahu Plaza, Jammu and Bagat-e-Barzulla, opposite J&K Bank Barzulla, Srinagar. The counselling will be held simultaneously from both the offices through video conferencing
- **Counselling Dates:** From 18<sup>th</sup> and 19<sup>th</sup> May as per Counselling Schedule indicated above.
- **Counselling Fee:** Rs. 1000/= (Rupees One Thousand only) for candidates attending counseling for the first time.
- **Point of Sale Terminals:** POS machines are installed in BOPEE offices. Candidates have to pay their Counselling Fee of Rs. 1000 (non-refundable) by using their Credit Card / Debit Card / ATM Card at these POS machines and attach receipt with the Counselling Form.
- **Registration Time:** 09:30 A.M. to 11:30 A.M. on all counselling days.
- **Presence of Candidates:** The candidates should be present personally in the counselling along with their Electronic Admit Card downloaded from BOPEE website(s). However, in exceptional cases, where candidates cannot appear personally due to some very urgent reason, he/she may be represented by an authorized person with prescribed Authority Letter as per Proforma provided in the Electronic Information Brochure along with the Electronic Admit Card.
- **Production of Documents:** The candidates are required to produce the following certificates in Original with one set of attested Xerox copies of the same: Date of Birth Certificate, State Subject/ Permanent Resident Certificate, MBBS Degree Certificate, Registration Certificate from



State Medical Council and Medical Council of India (wherever applicable), Reserved Category Certificate, Difficult Area Certificate and Rural Service Certificate (wherever applicable).

- **Discipline/Institution Allotted:** The allotment of seats (discipline/institution) shall be made strictly on the basis of merit, choice of the candidate and availability of seats at the time of counselling.

**Note:**

1. The Rank/Roll No.'s given in above (and in related list on website) are subject to verification with reference to original documents of the candidate and marks secured in the Entrance Test and mere mention of the Rank/Roll No. given above (and in related list on website) will not accrue any right to the candidate who is otherwise found ineligible.
2. The admission, recommended in ASCOMS is subject to the approval of MCI and affiliating University.
3. Students are advised, in their own interest, to visit BOPEE website(s) daily in order to know the latest Seat Matrix.
4. The counselling for allotment of Streams and Institutions will be strictly as per the procedure in Electronic Information Brochure-2016 on pages 33-35 under heading COUSSELLING FOR ALLOTMENT OF DISCIPLINES/STREAMS.
5. Every candidate, before counselling, will be required to sign an undertaking that he/she:-
  - a) will not indulge in any act of ragging;
  - b) is not presently pursuing any other course at the Govt. expenses; and
  - c) is not an in-service candidate or is an in-service candidate whose Application Form has been duly forwarded by the Director, Health Services, Jammu/ Kashmir/ Competent Authority.

**II. Waiting List:**

1. All the eligible candidates of MD/MS/PG Diploma Courses-2016 may exercise/indicate their choice(s) in order of preference on the prescribed format (available on the official website [www.jakbopee.org](http://www.jakbopee.org) / [www.jakbopee.net](http://www.jakbopee.net)) against such seats as may become available due to any reason for **preparation of waiting list** for admission and submit the same positively in the BOPEE office Srinagar/Jammu by or before **24<sup>th</sup>** May, 2016.
2. The selection/admission of candidates against such seats in various Institutions will be made on the basis of their preference from the waiting list subject to their Rank, Category and Merit.
3. No preference of choice will be entertained for inclusion in the waiting list after the said date.
