**Public Notice No. 022-BOPEE of 2017 Dated 15-04-2017**

The aspiring candidates of NEET PG (MD/MS/PG Diploma & MDS Courses) are making repeated calls to the BOPEE about NEET PG Online counselling result. Board had earlier notified the date between 4<sup>th</sup> to 15<sup>th</sup> April, 2017 for purpose. However, due to increase in the seat matrix on various occasions and the time given to the candidates to update their preferences and the latest one having expired on 14-04-2017 midnight, it will take few days for the Board to update the process. Further, some cases, which are pending adjudication before the Hon'ble High Court at Srinagar/Jammu, and interim directions have also been issued, are listed in the coming week. One of the petitions is reported to have already been dismissed by the Hon'ble High Court in the last week but details have not been received by the Board so far in view of the holidays. Therefore, after these issues are resolved, the Board shall take immediate necessary action to notify the list.
