Subject:- Provisional State Merit List (PSML) of MD/MS/PG Diploma & MDS Courses – PG NEET 2017 – eligibility under Rural Service Quota – Examination/consideration of representations.

Notification No. 031-BOPEE of 2017 Dated 19-04-2017

Whereas, vide Notification No. 028-BOPEE of 2017 dated 09-04-2017, the case of Dr. Neeru Pangotra, MDS candidate with Testing ID CD1759497 with regard to her eligibility under Rural Service was kept under examination in view of a complaint received against her; and

Whereas, the matter was taken up with the Deputy Commissioners, Samba and Udhampur in light of the complaint with a view to ascertaining the distance from the municipal limits; and


Whereas, both the Deputy Commissioners have certified that the area Thail falls more than 20 Kms away from the municipal limits; and

Whereas, in light of the reports, the matter has been examined and considered and the candidate found eligible in terms of SRO 294 of 2005 under Rural Service Quota; and

Whereas, the matter has also been examined in light of the status of Dr. Neeru Pangotra vis-à-vis Scheduled Caste category and it has been found that the candidate has secured more than 50 percentile marks in the NEET examination and at the time of filling up of the documents with the BOPEE, she staked a claim only under Rural Service and not under Scheduled Caste Category. Therefore, for all practical purposes having qualified the NEET examination with the Open Merit cut off marks, she is eligible to be considered in the Open Merit category subject to availability of seat and preference.

Now, therefore, Dr. Neeru Pangotra, Testing ID CD1759497 is hereby declared eligible for consideration under Rural Service Quota in MDS. However, this shall not confer any right upon her to be selected for MDS, which shall depend upon the merit-cum-preference along with availability of seats.

This issues without prejudice to the outcome of writ petition pending, if any, before any competent Court of law.
