Filling up of MD/MS Management seats of ASCOMS, Jammu through Joint Counselling by J&K BOPEE.

## Public Notice No. 22-BOPEE of 2017 Dated 20 -04-2017

In view of the decision of the Government of India to fill the management quota seats also through joint counselling, the BOPEE has already notified the same vide Notification No. 013-BOPEE of 2017 dated 13-03-2017. The candidates were also given option to update their preferences as a consequence of change in the seat matrix due to above and increase in number of seats in GMC, Srinagar at the relevant point of time.

The seats under the management quota shall, therefore, be filled only out of the candidates who have applied for the same, on the basis of their merit-cum-preference. However, the following seats shall be filled up after the declaration of the NEET PG result (first counselling) after scrutiny of documents of such candidates who have applied for the same in the joint counselling online submission of forms:-

Hindu Minority seats
 NRI Quota seats

The candidates shall be required to present themselves in person on the appointed date, time and place as may be notified by the Board along with all documents. The other terms and conditions for filling up of these seats including on the basis of merit-cum-preference and the eligibility for such seats shall remain the same.
