Subject:- Final State Merit List of NEET MDS candidates-2017.

Notification No. 032-BOPEE of 2017 Dated 21-04-2017

Whereas, the Provisional State Merit List of NEET MDS candidates, 2017 was notified vide Notification No. 008-BOPEE of 2017 dated 25-02-2017; and

Whereas, it has been felt expedient to notify the Final State Merit List of such candidates before list of candidates selected for admission in MDS Courses, 2017 is released.

Now, therefore, the Final State Merit List of MDS candidates, 2017 is notified as Annexure 'A' to this Notification (available on the official website of BOPEE www.jakbopee.org). However, S.No. 2 Dr. Rizwan Hamid has been declared ineligible for competing in the process in accordance with SRO 8 of 2005 dated 18-01-2005.

This shall, however be subject to Rule 12 of the SRO 158, which is re-produced hereunder:-

“If at any stage it is detected by the Competent Authority or the Principal of the Medical College concerned that any candidate has secured admission to a Post graduate Degree or Diploma Course by fraud, concealment of facts or mis-statement, the admission of the candidate shall stand cancelled and such a candidate shall also stand debarred from seeking admission to any Post graduate Degree and Diploma Course in future and shall also be liable to criminal proceedings.”

This issues without prejudice to the outcome of writ petitions, if any, pending before any competent Court of Law.
