Subject to having passed B.A./B.Sc./B.Com./B.C.A./B.B.A. or its equivalent examination from a recognized University/Institution according to 10+2+3 pattern with not less than 50% of marks in aggregate in the qualifying examination in case of Open Merit candidates and 45% of marks in aggregate in case of Reserved Category candidates on or before the date of declaration of result for B.Ed. Kashmir-2016, and consequent upon shortfall received from the Principal Govt. College of Education, Srinagar, the candidates figuring in the annexed list, have been provisionally selected for admission to B.Ed. (Kashmir) Course-2016 for Govt. College of Education, M.A. Road Srinagar. The Principal of the College concerned will get the following certificates in original verified from the incharge admission and countersigned by him/her before allowing the candidates to complete their admission formalities.

- (i) Qualifying Marks Certificate;
- (ii) Permanent Resident Certificate;
- (iii) Category certificate, if any; and
- (iv) Character Certificate

The candidates are directed to report the Govt. College of Education M. A, Road Srinagar upto **14th of June, 2016 upto 4:00 P.M** along with their relevant Certificates in **Original** and the **Electronic Admit Card** downloaded by them from the official website(s) of BOPEE.

The Head of the Institution is also requested to send within the prescribed last date the Roll Nos., Rank and Names of the candidates who will not complete their admission formalities or who may be otherwise ineligible for having failed to pass the qualifying examination with the requisite percentage as **SHORT FALL** on **14th of June, 2016** upto 5.00 P.M. to the BOPEE office, Srinagar/Jammu positively. In view of the shortfall received from the Principal Govt. College of Education Srinagar, the candidates bearing following Ranks; 0190 (JKPM) and 0191, 0193, 0194 (RBA) selected vide Notification No. 24-BOPEE OF 2016 Dated: 07-05-2016 may be treated to have been selected in Open Merit.

1. The Application Forms for admission to B. Ed. course were invited from the candidates including those whose result of qualifying examination was awaited. Thus, mere enlisting of any candidate in the annexed list will not accrue any right to him/her, if found otherwise ineligible.
2. Rank 0169, 0174 (OM), 0313 (SC), 0329, 0386 (STK) and 0385, 0423 (RBA) have been selected in B.Ed. (Kashmir) based on their application submitted to this office for correction/change of Course from B.Ed. (Special Education) to B.Ed. (Kashmir). Rank 0251, 0304 (RBA) who missed their admission have been selected based on their application submitted to this office for the said purpose.
