## Admission Notification for Common Entrance Test(II)-2016

Notification No. 37-BOPEE of 2016 Dated: 06-06-2016

As per the provisions of the Indian Medical Council (Amendment) Ordinance, 2016, No 4 of 2016 and the instructions conveyed by the State Govt. vide its letter OM.No.TRB/RES/20/2016 dated: 26-5-2016, Online Applications are invited from the eligible candidates interested in appearing in the Common Entrance Test (CET-II)-2016 for admission to MBBS and BDS Courses only. The candidates who had applied for Common Entrance Test held on May 14<sup>th</sup> and 15<sup>th</sup> (here-in-after referred to as CET-I) and those who did not apply are eligible to apply afresh. All the terms, conditions, guidelines and instructions notified vide notification01-BOPEE of 2016 dated: 19-01-2016 shall also apply to the candidates applying for CET-II.

Note:- **All the candidates have to necessarily apply afresh.**

### Online Application Forms:

The Application Forms have to be **submitted online only** through BOPEE websites [www.jakbopee.org](http://www.jakbopee.org) / [www.jakbopee.net](http://www.jakbopee.net) (through URL's/ links provided for this purpose) from **7<sup>th</sup> June to 17<sup>th</sup> June, 2016**. The payment of rupees 400 (Rupees four hundred only) as fee is to be made also online through the HDFC integrated Payment Gateway which can be used to make payment with any national Credit Card/Debit Card/ and also by downloading online generated Bank Challan of J&K Bank/HDFC Bank for depositing the fee amount, in any branch of J&K Bank or HDFC Bank, directly in the BOPEE Account. The candidates who had applied for CET-I and were allotted Roll No. have to enter **correctly** their Entrance Test Roll No. of CET-I in addition to other details in the Online Form. The candidates who were not allotted Roll No. for want of eligibility have to fill all the required details, provided they are now eligible. The procedure for filing Application Form and eligibility for the candidates who have to apply afresh has been given in detail in the E-Brochure. The applicants must necessarily, in their own interest, go through this e-Brochure before attempting to fill up the online Application Form.

The applicants are advised to fill the online Application Forms on their own or through a responsible person. The applicants can also avail services at the Common Service Centres (**Khidmat Centres/VLE**) of J&K State for filling up online Application Form at nominal charges. The rate list for various services to be availed at **Khidmat Centres** is available on the official website of the BOPEE. The applicants can also contact the **Help Desk** of I.T. ### Submission of Online Application Forms:

The candidates have to keep following original certificates ready

- (i) Permanent Resident Certificate;
- (ii) Qualifying marks certificate;
- (iii) Date of Birth Certificate ; and
- (iv) Reserved category certificate, if any, (The candidates claiming benefit of being outstanding sports persons and who had applied for CET-I need not to submit their sports certificates to sports council. However the candidates who claim benefit of being sports persons but have not applied for CET-I have to submit their certificates to the sports council for evaluation and award of points which will be then officially forwarded to the BOPEE
- (v) Note: The benefit of P&B certificate is available for admission in MBBS course in private Medical College

The candidates can change/ modify their online Application Form at any time before they submit it online. They are advised, in their own interest, not to share their login details with anybody, lest he/she may get an opportunity to change important details in the Application Form.

**Note: The candidates must CORRECTLY enter the details of CET-I where ever required, otherwise they will not be able to download their admit card. The candidates must, after filling up all the required entries, submit their Application Form by pressing SUBMIT BUTTON, otherwise their Form will not come in the database and will not be considered. Mere downloading of the Application Form/Confirmation Page does not mean that the candidate has submitted his / her Application Form.**

**Eligibility for appearing in CET-II 2016:**

1. The Applicant must:
  - a. be a permanent resident of J&K State as defined in section 6 of the Constitution of J&K;
  - b. have passed higher secondary Part-II (12<sup>th</sup>/10+2 class) or an equivalent examination from a recognized statutory Board with at least English, Physics, Chemistry and Biology as his/her subjects and
  - c. have obtained at 10+2 level not less than 50% marks in case of open merit candidate and not less than 40% marks in case of ST, SC and OBC candidates.

Note: Result awaited candidates are not eligible to apply.

**Age Limit:**

The candidates must be at least 17 years old on or before 31<sup>st</sup> of December, 2016.

**Note:**

- a) Candidates are advised to upload Online Application Form under the guidance of their parents/Guardians.
- b) The information provided by the candidates in the online Application Form cannot be verified from his/ her original documents by the BOPEE officials before counselling for admission of the candidates. The information of the candidate in the online Application Form or on his/her roll no slip/ Admit Card shall in no case be construed as an acceptance of that information/category certificate by the BOPEE. Therefore, if at any stage, it is discovered that a candidate has provided false or incorrect information/ invalid certificate/photograph in respect of any eligibility condition, his/her candidature will be cancelled without any further notice and will be liable for prosecution under relevant laws.
- c) The candidates must create in their own interest an e-mail ID and should enter functional Telephone no. at the relevant place in the Application Form for receiving e-mail or SMS for further updates.
- d) The Candidates are hereby sternly warned not to resort to any unfair/fraudulent means or act of impersonation at the time of Entrance Test. In case a candidate is found taking recourse to such acts, criminal prosecution shall be launched against him/her and his/her parent/guardian/abettors. He /she shall be permanently debarred from appearing in any future CET.

**Original Documents required at the Time of Counselling:**

- a) Marks certificate of the qualifying examination (12<sup>th</sup> class)
- b) Date of Birth (Matriculation Certificate/Secondary School Certificate) from the Board of School Education.
- c) Permanent Resident Certificate.
- d) Reserved category Certificate, if any, on the prescribed proforma.

*The candidates having more than one reserved category certificate can get benefit of only one category indicated in the Application Form which in no case shall be changed afterwards. The candidate, whose category certificate is not found valid, will be considered in open merit, if found otherwise eligible without any further notice.*

If a candidate feels aggrieved by the decisions of the BOPEE regarding distribution or clubbing of fractional seats of reserved categories published in the E-Brochure CET-II 2016, he/ she is free to make representation to the Secretary BOPEE on any working day by or before 30th June 2016. Thereafter, no such representation will be entertained.

**Roll No Slip/Admit Card:**

The notification for downloading of admit cards will be issued separately. The candidates who fail to download their admit cards must report in the office of the BOPEE Srinagar/Jammu immediately. The admit card will indicate time, Venue and schedule of the Entrance Test. The Admit card will be having space for photograph of the candidate. The candidate has to affix his/her photograph which should be then attested by the Gazetted Officer. A candidate will not be allowed to appear in the Entrance Test without the Admit Card with his attested photograph. The candidates are advised to remain in touch with the official Website of BOPEE for updates for Centre notification and for other important information relating to CET-II 2016. The candidates will receive SMS and e-mails for updates.

**Date and Meetings:**

There shall be two meetings of the Entrance Test which will be held on the same day in the forenoon and afternoon on 31<sup>st</sup> July (Sunday).
