



**SUBJECT : Up-gradation Round for MD/MS/PG Diploma, 2017**

Public Notice No. 026-BOPEE of 2017

Dated: 12-05-2017

Candidates have been seeking clarification as to whether they are eligible for up-gradation if they joined the allotted seat and fill-up the status retention form. In this connection attention is invited to the Public Notice 008/BOPEE of 2017 dated 08.03.2017 wherein the position has been clarified.

For facilitation of the candidates the para is reproduced as under:-

“any seat(s) falling vacant due to non-joining/resignation etc of the candidate(s) shall be filled up by upgradation on the basis of (Merit-Cum) Preference only. Any candidate/all such candidates who has/have submitted the Status Retention Form and claim(s) upgradation against the said seat(s)/college(s) shall be eligible to stake a claim and the allotment of such a vacant seat shall be considered only on the basis of Merit-Cum-Preference already indicated by the candidates. The resultant seat/seats as may fall vacant consequent upon such an upgradation shall be filled up in the subsequent round(s) of counselling in accordance with information contain in the Brochure.”

Candidates desirous of participating in the upgradation round shall be required to submit the following information alongwith photocopy of admission receipt on the e-mail: [mdmspzd@gmail.com](mailto:mdmspzd@gmail.com) or in person in the Board Office at Srinagar/Jammu upto 16<sup>th</sup> of May, 2017 (5PM). However, (C.N.A) candidates who have not been allotted any seat due to non availability



of seats as per their preferences shall also be considered for allotment of seat if available during the upgradation process.
