
Notification No. 048-BOPEE of 2017 Dated 29-05-2017

Consequent upon the dismissal of SLP (C) No. 016438/2017 titled "Board of Professional Entrance Examinations Vs Dr. Shahnawaz Choudhary & Ors" by the Hon'ble Supreme Court filed against LPA No.85/2017 by the BOPEE and extension of fifteen days time granted by the Hon'ble Supreme Court for completion of admission in the MD/MS/PG Diploma Courses, 2017 viz upto 15-06-2017, a revised merit list of MD/MS/PG Diploma, 2017 candidates is hereby notified as Annexure 'A' to this Notification (available only on official website of BOPEE). The merit list has been re-drawn by giving a weightage of 10% incentive per year subject to a maximum of 30% in accordance with the MCI regulation 9(IV) to the candidates who have worked in difficult areas and submitted 'the requisite documents' in the Board Office within the specified time.

Further, consequent upon dismissal of writ petitions titled Dr. Mushtaq Ahmad Dar & Ors V/s State and Ors, Dr. Mohammad Obeid Haq & Ors. Vs State of J&K & Ors. and Dr. Aijaz Ahmad Bhat & Ors.Vs State of J&K & Ors., by the Hon'ble High Court, J&K, Srinagar vide its order dated 22-05-2017, wherein rural service quota has been held ultra vires and the candidates held ineligible by the Hon'ble High Court under 10% rural service quota, it has been decided to add the 10% rural service quota seats to the Open Merit quota. The revised quota shall, therefore, be 75:25 i.e. 75% seats in Open Merit and 25% seats in reserved category.

The candidates who wish to update their preferences may do so w.e.f. 29-05-2017 8.00 p.m. to 01-06-2017 5.00 p.m. after which the Board shall consider the matter and issue the fresh admission list on the basis of merit-cum-preference. The candidates can also avail the facility at NIC in the district headquarters for updating the preferences.

In view of revision in the quota, the revised seat matrix is annexed as Annexure 'B' to this Notification (which is also only available on official website of BOPEE).
