Public Notice No. 033-BOPEE of 2017 Dated 31-05-2017

After issuance of notification regarding the re-drawn merit list vide Notification No. 048-BOPEE of 2017 dated 29-05-2017 issued in compliance of the judgement of the Division Bench dated 19-05-2017 in the case titled J&K BOPEE Vs Dr. Shahnawaz Choudhary & Ors read with orders of the Hon'ble Supreme Court dated 29-05-2017 in SLP Nos.15859-15860/2017 the Board has been receiving complaints that areas indicated in the certificates issued by the Directors of Health Services, Jammu/Kashmir, under SRO 401/201 do not fall in the notified areas, on the basis of which the benefit of weightage in marks stand granted. The attention of the candidates is invited to SRO 158, the relevant part is re-produced hereunder:-

“If at any stage it is detected by the Competent Authority or the Principal of the Medical College concerned that any candidate has secured admission to a Post graduate Degree or Diploma Course by fraud, concealment of facts or mis-statement, the admission of the candidate shall stand cancelled and such a candidate shall also stand debarred from seeking admission to any Post graduate Degree and Diploma Course in future and shall also be liable to criminal proceedings.”

In case at any point of time, it is proved that any candidate admitted to the medical colleges/institutions has produced a false certificate, with respect to Difficult Area or any other ground on which he has sought admission, the same shall be cancelled abinitio. The Directors Health Services, Kashmir/Jammu shall be held responsible for issuance and verification of such certificates.
