

MD/MS/PG Diploma candidate who are participating in the upgradation/physical round counseling are hereby informed that:-

1. They shall not be allowed to carry mobile phone(s) inside the counselling committee room;
2. The admission of candidates, involved in canvassing, shall be liable to be cancelled;
3. Indiscipline of any kind during the counselling shall make such candidate liable for punishment/cancellation of the admission;
4. The candidates shall be called by the counselling committee in order of merit and only one candidate shall be allowed at one point of time ;
5. Since the seats shall vary from minute to minute, the candidates shall be given option to make necessary changes in their preference forms;
6. The candidates shall be considered against the seat available at the relevant point of time and in case of his/her non availability at such a time, he shall not have any claim over such a seat, and the seat shall be allotted to candidate next in merit/preference by that time.
7. Any concealment of information/misrepresentation of facts by any candidate shall make his/her admission liable to be cancelled.
