Submission/verification of documents of NEET UG, 2017 candidates.

Public Notice No. 052-BOPEE of 2017 Dated 03-07-2017

Whereas, on the basis of NEET UG result, the tentative merit list of the candidates, who have qualified the NEET UG examination has been notified vide Public Notice No. 050-BOPEE of 2017 dated 01-07-2017; and

Whereas, also a revised schedule for document verification has been notified vide Public Notice No. 051-BOPEE of 2017 dated 01-07-2017; and

Whereas, the matter has been examined by the Board further and following has come to fore:-

- 4) Number of candidates who have qualified the NEET examination is 12376;
- 5) Ratio of seats to candidates who qualified, therefore, approximately is 18 times;
- 6) It is, therefore, undesirable to conduct verification of all the candidates, who have qualified the examination in view of limited number of seats and large number of candidates, who have qualified the NEET examination, as such an exercise will cause hardships to the candidates;

Whereas, the matter has been examined in the light of above, and it has been decided as under:-

- i) To restrict the number of candidates to be called for verification of documents in the OM category upto 2000 i.e. upto 314 NEET score;
- ii) Allow all candidates belonging to reserved categories to submit the documents in the BOPEE office for updation of their category status etc.

Now, therefore, in supersession of Public Notice No. 051-BOPEE of 2017 dated 01-07-2017, it is hereby notified that:-

- a) OM candidates, who have scored 601 (to down below) 314 NEET score shall be allowed to submit the documents at Board Office;
- b) All category candidates who have qualified NEET shall deposit their documents in the BOPEE Office at Srinagar/Jammu;

Accordingly, the revised schedule for submission of documents shall be as under:-

It is, further notified that the candidates who are not called for document verification shall be included provisionally in the State Merit List and if need be they shall subject to requirement, be called for verification of documents at appropriate time.

Note:- The State Subject Certificate/category certificates should be issued upto the last date of deposition of documents viz 08-07-2017. No certificate issued after this date shall be entertained at a later date.
