2. The candidates who could not indicate the category status at the time of filling up of online application forms shall be eligible to produce the valid category certificates. The cut-off date for valid certificates shall be the last date of filling of Online application forms viz 01-03-2017 as also notified vide public notice no. 3-BOPEE of 2017 dated 25-2-2017. However in respect of candidates, with the age above 25 years who were allowed to fill in the forms subsequently the cut of date shall be 5-4-2017
3. The candidates who do not have valid category certificates on the cut off date shall be treated as Open Merit candidates.
4. The candidates shall have to fill in the check list /bio-data form as annexed with the notification. The candidate shall also be required to produce the NEET result card/ proof of identity. The candidates who fail to deposit the documents shall not be eligible to participate in further counselling process in any case. No proxy candidates shall be allowed.
5. No "under process" certificate shall be entertained.
6. Board may review the above schedule notified if it is of the opinion that such a review is necessary
