Subject:- Filling up of MBBS/BDS Management and NRI Seats of ASCOMS and IDS Jammu through common counselling by J&K BOPEE.

Public Notice No. 057-BOPEE of 2017 Dated 11-07-2017

Consequent upon Medical Council of India Amendment Notification No. MCI-34(41)/2016-Med/176-286 dated 10-3-2017 and communication No. 11011/1/2015-MEP(PT) dated 10-3-2017 from Ministry of Health and Family Welfare (Medical Education Policy) Government of India, all the MBBS and BDS seats of ASCOMS and IDS, Jammu, even those under Management and NRI quota, shall be filled up by the J&K BOPEE through Joint/Common Counselling.

A. The following MBBS Seats are available in ASCOMS and shall be filled up accordingly:-

1. Government Seats = 40 OM
2. Poor & Backward Seats = 10
3. Management Quota seats = 40
4. NRI Seats = 10.

B. The following BDS Seats are available in IDS and shall be filled up accordingly:-

1. Government Seats= 40
2. Management Quota seats= 50 (inclusive of seats reserved for Hindu Minority as per rules)
3. NRI Seats= 10

Subject to further clarification from the Government with regard to the eligibility governing the filling up of seats under Management/NRI Quota in ASCOMS/IDS, the following shall be the eligibility criteria:-

Category No. 1 :- Where applicant himself/herself is NRI and family originally belongs to J&K State.

Category No. 2 :- Children/wards of NRI who originally belong to State of J&K.

General Conditions:-

1. Should have applied under NEET and have qualified/obtained minimum score of 314.
2. Should also have deposited documents with the BOPEE in response to Public Notice No. 052-BOPEE of 2017 dated 3-7-2017. However, any eligible candidate as above, who has not deposited the documents upto 3-7-2017 may do so upto 15th of July 2017 at BOPEE Office, Srinagar/Jammu during office hours.
3. In case of Non availability of candidates for NRI quota, the seats shall be allotted to the existing eligible candidates by Merit Cum Preference.

The fee fixed by the State Government for MBBS seats of ASCOMS vide Government Order No. 221-HME of 2016 dated 1-4-2016 and Government order No. 307-HME of 2017 dated 8-6-2017 for BDS seats in IDS Jammu is given as under:-

MBBS in ASCOMS

1. Government Seats under OM= Rs 4.50 lacs per annum per student
2. Government Seats under P&B category= Rs 0.39 lacs per annum per student
3. Management Quota seats= Rs 4.50 lacs per annum per student
4. NRI Seats= US Dollars \$ 19565

BDS in IDS

1. Government Seats under OM= Rs 3.45 lacs per annum per student

BSW

2. Management Quota seats= Rs 3.45 lacs per annum per student
3. NRI Seats= Rs 5.50 lacs

Further, the documents required for NRI Category 01 and 02 above candidates, should be as under:-

Category 1

- a. NEET UG Score card -2017;
- b. NRI Certificate issued by the Ministry of External affairs, Government of India or Indian embassy overseas under Ministry of External affairs with holding of Indian passport;
- c. NRI bank account preferably in the country where the candidate is residing or of NRI account in India;
- d. Copy of Indian passport;
- e. Copy of Income Tax return filed in India, if any,
- f. Pan Card No., If any, and
- g. State Subject certificate of the candidate.

Category 2

- a. NEET UG Score card -2017;
- b. NRI Sponsorship letter;
- c. Undertaking of NRI duly attested by the legal authority of that country where sponsor is residing or Indian overseas embassy;
- d. Bank statement of Sponsor;
- e. Resident/National Certificate or NRI Certificate of the Sponsor;
- f. Pedigree table/family tree establishing relationship of candidate with the sponsor along with documentary proof;
- g. Employment certificate of the sponsor;
- h. Pan Card No., If any of the sponsor;
- i. Pan Card No., If any of the candidate/ parents;
- j. Copy of Income Tax return filed in india, if any; and
- k. State Subject certificate of the candidate.

NOTE 1.

The above documents are required in addition to all other documents that the candidates were required to submit before the Board as in conformity with the e-brochure

NOTE 2.

The cut off marks for being eligible for submission of documents in pursuance of Public Notice No. 052-BOPEE of 2017 dated 3-7-2017 shall be 314. No candidate with a score below 314 shall be eligible for consideration in the first round of counselling. However the notifications/modifications Board reserves the right to modify the eligibility with regard to cutoff score depending upon the decisions as may be taken by the Board from time to time.
