Subject:- Filling up of MBBS/BDS Management and NRI Seats of ASCOMS and IDS Jammu through common counselling by J&K BOPEE – extension of date thereof.

Public Notice No. 059 -BOPEE of 2017 Dated 16-07-2017

In continuation of Public Notice No. 057-BOPEE of 2017 dated 11-07-2017, it is hereby notified that:-

1. the date for submission of documents by the candidates eligible as per Public Notice No. 057-BOPEE of 2017 dated 11-07-2017 under NRI quota for seats in ASCOMS/IDS for MBBS/BDS is hereby extended up to 1st of August, 2017;
2. the candidates who have qualified the NEET examination up to a score of 131 but are eligible otherwise as per the conditions of the above Public Notice shall also be eligible for submission of documents/staking a claim;
3. The selection of the candidates under the NRI quota shall be made strictly on the basis of merit obtained by the candidates in the NEET UG examination, 2017 and on verification of documents by a Committee including the representatives of the concerned Colleges as may be constituted by the Board for the purpose;
4. The candidates shall have to submit necessary proof of being eligible for consideration under NRI quota and this shall be subject to such other conditions as may be notified by the Board from time to time in accordance with rules/procedures and the undertakings as may be required to be furnished by the candidates with regard to payment of fee etc.

- Note:-
1. The candidates who are otherwise eligible and belong to the State of Jammu and Kashmir and have applied under the State quota of ASCOMS/IDS/OM quota under management quota shall be considered on the basis of merit cum preference as may be indicated by such candidates while filling up the online preference forms for which the date shall be notified separately.
 2. The candidates applying under NRI as per the Public Notice No. 057-BOPEE of 2017 dated 11-07-2017 read with the present Public Notice No. 059-BOPEE of 2017 dated 16-07-2017 are, in their own interest, also advised to keep all the documents available for verification by the Committee as may be constituted for the purpose.

3. Mere submission of biodata or the details shall not confer any right on any candidate to claim admission under NRI quota which shall and shall be filled up in accordance with the rules/procedures.
4. The candidates applying under minority quota should fulfill the conditions of eligibility as otherwise contained in respect of candidates in the OM category who have been called to deposit the documents by the BOPEE with a cut off score 314. They shall be required to indicate, at the time of filling up of online preference forms, that they belong to Hindu minority and shall be required to produce a certificate in this regard from the concerned competent authorities of the State Government/concerned Revenue Authority otherwise competent to issue the State Subject certificate.

This shall be subject to the clarification with regard to the eligibility of the candidates under NRI quota from the State Government with whom the matter has already been taken up.


