Subject:- Disposal of representations against CET list notified vide Notification No. 080-BOPEE of 2017 dated 26-07-2017.

Reference:- Public Notice No. 064-BOPEE of 2017 dated 27-07-2017

Notification No. 081-BOPEE of 2017 Dated 29-07-2017

Whereas, the CET admission list was notified vide Notification No. 080-BOPEE of 2017 dated 26-07-2017 and the candidates were given an opportunity to make representation, if any, vide Public Notice No. 064-BOPEE of 2017 dated 27-07-2017 up to 29-07-2017 upto 4.00 p.m; and

Whereas, representations received as such have been examined and it has been found as under:-

1. Allotment to Rank 296 and 916 has been made on the basis of Open Merit although they belong to TFW category;
2. The SC candidate with Rank 637 had made the payment during the mock exercise which payment was not reflected in the server and was not considered for allotment of a seat;
3. Some candidates belonging to the OM had represented against allotment of seats to category candidates in the OM with an allotment of stream higher in preference than the representees.

After due examination, it has been decided as under:-

- a. To update the status of TFW candidates from OM to TFW with consequential changes as may become necessary;
- b. Include Rank 296 in the admission list with consequential changes as may become necessary;
- c. The allotment of category candidates in OM in GCET is in accordance with Rule 17 of the Reservation Rules of 2005. The Board has also notified the particulars of candidates in whose case Rule 17 has been applied copy whereof is available on the website;
- d. To update the admission list as notified vide Notification No. 080-BOPEE of 2017 dated 26-07-2017 and to place the same on the website of the BOPEE.

Now, having considered the matter, therefore, the updated CET admission list with all consequential changes to Notification No. 080-BOPEE of 2017 dated 26-07-2017 is annexed herewith as Annexure "A" to this Notification, copy whereof is placed on the official website of the BOPEE.
