Subject to having passed B.A./B.Sc./B.Com./B.C.A./B.B.A. or its equivalent examination from a recognized University/Institution according to 10+2+3 pattern with not less than 45% of marks in aggregate in the qualifying examination in case of Open Merit candidates and 40% of marks in aggregate in case of Reserved Category candidates on or before the date of declaration of result for B.Ed. Kashmir/Special Education-2017, and in view of willingness expressed by them to be allotted B.Ed. (Special Education) in CRC, the candidates figuring in Annexure "A" (Third List) to this notification, have been provisionally selected for admission to B.Ed. (Special Education) Course-2017 in **Composite Regional Centre (CRC), Bemina, Srinagar** (Ministry of Social Justice & Empowerment, Govt. of India). The Principal/Director of the College will get the following certificates in original verified from the Incharge admission and countersigned by him/her before allowing the candidates to complete their admission formalities.

- (i) Qualifying Marks Certificate;
- (ii) Permanent Resident Certificate;
- (iii) Category certificate, if any;
- (iv) Character Certificate and
- (v) Date of Birth (DOB) Certificate


The candidates shall report the **Composite Regional Centre (CRC), Bemina, Srinagar** upto **10th of August, 2017 (4:00 P.M.)** along with their relevant Certificates in **Original** and the **Electronic Admit Card** downloaded by them from the official website(s) of BOPEE.

The Head of the Institution shall send within the prescribed last date the Roll Nos., Rank and Names of the candidates who fail to complete their admission formalities or who may be otherwise ineligible for having failed to pass the qualifying examination with the requisite percentage as **SHORT FALL** on **10th of August, 2017 upto 5.00 P.M.** to the BOPEE office, Srinagar/Jammu positively.

NOTE:

1. The Application Forms for admission to B. Ed. Kashmir / B.Ed. (Special Education)-2017 courses were invited from the aspiring candidates including those whose result of qualifying examination was awaited. Thus, mere enlisting of any candidate in the annexed list will not confer any right upon him/her to claim admission, if otherwise found ineligible.
2. The details of candidates found ineligible, if any, shall be submitted by the college to the Board along with the shortfall.
3. Candidates who have submitted their application of interest for admission to B.Ed. (Special Education) Course in CRC only, pursuant to this office PUBLIC NOTICE No. 024-BOPEE of 2017 Dated: 09-05-2017, or through Applications thereafter are only included in this Select List.
4. As a consequence of non availability of category candidate(s) in the List of Applications received, pursuant to the above said public notice, during the selection process the category seat(s) has/have been added into Open Merit (OM) category.
