In addition to the above, the candidates should also fulfil the following conditions:-

1. The candidates should have appeared in the Common Entrance Test-II, 2016 and indicated his/her CET-II, 2016 Roll No. with Marks and Rank.
2. The candidates will be nominated/selected by the Ministry of Home Affairs, Government of India, New Delhi strictly on the basis of his/her merit and rank obtained in the CET-II, 2016.
3. The J&K BOPEE will forward two sets of application forms alongwith requisite documents to the Ministry of Home Affairs, Government of India, New Delhi.
4. The candidates should submit the Police Verification/Authentication Certificate duly countersigned by Administrative Secretary to Govt. J&K Home Department.
5. The candidate who fails to submit the said documents within the above stipulated time shall not be forwarded to the concerned Ministry considered for nomination/selection of the Central Pool Seat under Home Ministry Quota.
6. The candidate must mention specifically the priority in which he/she applies.
