Consequent upon the third round of Counselling held on 24<sup>th</sup> September, 2016 at BOPEE Office Bagati- Burzulla Srinagar and Bahu Plaza, 4<sup>th</sup> Floor, South Block, Jammu, simultaneously through Video conferencing, as per Notification No. 86-BOPEE of 2016 Dated: 11-09-2016, for admission to MBBS, BDS & DDH in Govt. / Private Colleges of J&K, the following candidates are provisionally recommended for upgradation/admission, on the basis of their merit/category and preference given by them in the counselling/(Prescribed Format for DDH), to the disciplines and institutions shown against each rank in the Annexure-I.

The candidates are directed to report for admission to the allotted Colleges/Institutions on or before **28**<sup>th</sup> **September, 2016 upto 04:00 P.M.** along with their relevant certificates in original and Online Admit Cards downloaded by them from the official websites of the Board.

The concerned Heads of the Institutions are requested to check the eligibility of the candidates and verify Permanent Resident Certificate, Marks Certificate, Date of Birth Certificate and Category Certificate, if applicable, in original along with Admit Cards to verify the identity of the candidates and genuineness of the certificates. The concerned Heads of the Institutions should send all the category certificates to the offices where these certificates have been issued so as to ascertain their genuineness and entitlement to the benefit of the category. Where a certificate has been found fake or forged, or is declared invalid by a competent authority, the concerned Head of the Institution shall immediately report the matter to the BOPEE office for cancellation of admission of such a candidate.

The Heads of the Institutions shall send the list of candidates admitted in different disciplines and shortfall category wise, if any, along with the Roll No's and Names of the candidates who have not taken admission, on **28**<sup>th</sup> **September**, **2016 upto 05:00 P.M.** positively to the BOPEE.

\*Admission of candidate bearing rank 02546 is subject to outcome of pending writ petition.

The Candidates, who have been provisionally recommended for admission, vide various notifications, to BDS in IDS, Jammu and could not report to the college for admission, due to varied reasons, can also report for admission to BDS in IDS, Jammu on 27<sup>th</sup> of September, 2016.

Further, eligible CET-II, 2016 candidates upto Rank 1502 (OM) upto Rank 3017 (Category) interested in admission to BDS in IDS, Jammu can approach the said college w.e.f.  $28^{th}$  to  $30^{th}$  of September, 2016 for filling up vacant seat(s), if any, but strictly as per rank / merit.
