Subject to having passed Hr. Sec. Part II (12th / 10+2) or an equivalent examination on or before the date of declaration of result of CET-I, 2016 from a recognized statutory Board/University with 50% marks in aggregate in case of open merit category and 40% in aggregate for reserved categories with English, Physics, Chemistry and Biology, as elective subjects for admission to **Medical Courses** and being permanent residents of J&K State, the CET-I, 2016 candidates given in the Annexure-1 are provisionally recommended for admission, on the basis of their merit and preference given by them in their **Preference Form** notified vide this office **Notification No. 43-BOPEE of 2016 Dated:13-06-2016**, to the various courses offered at **Composite Regional Centre, Bemina, Srinagar (Ministry of Social Justice & Empowerment, Govt. of India)** shown against each rank.

The candidates are directed to report for admission on or before **18th October, 2016 upto 04:00 P.M.** along with relevant certificates in Original and Electronic Admit Card downloaded by the candidates from the official websites of the Board.

The Incharge Admissions is requested to check the eligibility of the candidates and verify Permanent Resident Certificate, Marks Certificate, Date of Birth Certificate and Category Certificate, if any, in original along with Electronic Admit Card to verify the identity and genuineness of the certificates. He is also requested to send all the category certificates for verification to the offices where these certificates have been issued so as to ascertain their genuineness and entitlement to the benefit of the category. Where a certificate has been declared invalid by a competent authority, the concerned Incharge Admissions is obligated to immediately report the matter to the BOPEE office for cancellation of admission of such candidate. The Head of the Institution shall send the list of candidates admitted in different disciplines and short fall (category wise), if any, along with Roll Nos. and names of candidates who have not taken admission on **18th October by 05:00 P.M.** positively to BOPEE office, Srinagar / Jammu by fax., email and by hand also.
