Subject: - 2nd Round of Physical counselling/allotment/up gradation of MBBS/BDS seats, 2017

Notification No. 102-BOPEE of 2017 Dated 18-08-2017

In continuation of Notification No. 095-BOPEE of 2017 Dated 14-08-2017, the seats as indicated below have fallen vacant for the reasons against each:-

Further, one seat of CDP (Male) in GDC-Srinagar as indicated above has remained unfilled. However, in view of time available for filling up of seats in Dental colleges upto 10th of September, it has been decided to give one more opportunity to the candidates belonging to CDP (Male) category candidates to compete for the said seat in the 1st instance which shall be in partial modification of Notification No. 095-BOPEE of 2017 dated 14-08-2017 in note 2.

The said seats shall now be filled on 24th of August, 2017 through physical counselling by allotment/upgradation. The Open merit candidates upto the score of 250 in the NEET and upto 131 in CDP category who are desirous of participating in the counselling shall be eligible for consideration. However, the eligibility for NRI seats in IDS shall be the same as Notified vide Public Notice No. 057-BOPEE of 2017 dated 11-07-2017 read with corrigendum dated 17-07-2017 and Public Notice No. 059-BOPEE of 2017 dated 16-07-2017.

The resultant seats if any due to allotment/upgradation shall also be filled up during the process of counselling on the same date/day.

Any candidate(s) desirous of being considered against the NRI BDS quota in IDS seats, but has/have not applied so far can also apply upto 23rd of August 2017 in the Board office at Srinagar/Jammu subject to fulfilment of conditions of eligibility as notified vide Public Notice 057-BOPEE of 2017 dated 11.07.2017 read with corrigendum No. BOPEE/Exam/-21/2017 dated 17.07.2017 and vide Public Notice 059-BOPEE of 2017 dated 16.07.2017. However, such candidates shall be considered only after their eligibility is determined by a committee as may be constituted by the Board and against the
