MD/MS Ayurveda-2016 Candidate Provisionally Recommended for Admission (03rd Allotment List)

Notification No. 112-BOPEE of 2016

Dated: 15-12-2016

Whereas, the admission notification was issued for inviting applications for admission to MD/MS Ayurveda-2016 Courses vide this office Notification No. 58-BOPEE of 2016 Dated 26-07-2016; and

Whereas, among other conditions for applying to the said courses among the eligibility conditions specified, one of the conditions specified was "as having obtained 50% marks in the qualifying examination"; and

Whereas, the requirement of submitting the category details of the candidates were not mentioned in the above said notification; and

Whereas, however, the online application form had options to select the category to which the applicant belongs to viz. OM, SC, ST and RG; and

Whereas, some of the applicants had mentioned their categories in their online application forms; and

Whereas, the result of the Entrance Test held on 30th of August, 2016 was declared and selection list was issued vide this office Notification No. 82-BOPEE of 2016 Dated: 08-09-2016 in which only 7 eligible candidates bearing ranks 1, 2, 3, 4, 5, 6 & 7 were recommended for admission to various disciplines of the Ayurveda against an allocation of 9 seats; and

Whereas, 2 seats were not filled due to lack of eligible candidates in the Open Merit; and

Whereas, on request of the College and candidates to fill up the vacant seats, the matter was taken up with CCIM to clarify if the SC candidates with relaxed standards can be considered who vide their letter Ref. No. 26-38/2016-College Dated: 18.11.2016 conveyed that the matter pertains to the State Government and enclosed a copy of the Indian Medicine Central Council Regulations, 2012 which inter-alia provides for 40% eligibility for SC/ST/RG, and

Whereas, in view of the above, 3 SC candidates with rank 8, 10 and 15 were recommended for admission vide this office Notification No. 109-BOPEE Dated: 25-11-2016 on the basis of their category eligibility and pursuant to shortfall of one candidate bearing rank 7 who had withdrawn her admission; and

Whereas, the college reported shortfall of one more candidate and requested for filling up the vacant seat; and

Whereas, no category candidate was found eligible for allotment of the said seat. However, one candidate with rank 11 represented before the Board with the plea that she is a SC category candidate, but had not mentioned the same in the Online Application Form, which she felt was not necessary as it was not mentioned in the admission notification; and

Whereas, a Public Notice was issued vide endorsement No: BOPEE/Exam-14/2016 Dated 14-12-2016 on the official website of BOPEE seeking interest of eligible candidates in admission to the said course for filling up the vacant seat who claim to belong to the category (SC/ST/RG); and

Whereas, applications of interest were received by BOPEE through email in this context from the candidates and after processing and examining the same it was found that one candidate with rank 11 having higher merit can be allotted the seat in view of the benefit of the doubt, that although being a Scheduled Caste candidate and in possession of the certificate before the cut of date, she had not mentioned the same in the Online Application Form as the admission notification did not indicate the requirement of being a member of any category. However, other candidate with rank 13 with lower rank can not be considered for allotment of the said seat as he

did not belong to the SC/ST/RG category but to some other category other than specified in the rules, as mentioned in the Online Application Form; and

Now, therefore, having considered the matter in totality in light of rules and circumstances of the case, following candidate is provisionally recommended for admission to **MD/MS Ayurveda** Course in Jammu Institute of Ayurveda & Research, Jammu.
