Consequent upon physical round of counselling for AYUSH Courses held from 08th to 12th of September, 2017 notified vide this office Notification No. 100-BOPEE of 2017 Dated 18-08-2017 and in continuation of this office Notification No. 114-BOPEE of 2017 DATED 07-09-2017 the second List of candidates allotted seats in various AYUSH/medical colleges of the State is annexed as **Annexure "A"** to this Notification.

The candidates who have been allotted seats shall report to the respective colleges up to 18-09-2017 4.00 P.M. along with the following necessary documents for admission:

1. Date of Birth Certificate;
2. Marks Card 10+2;
3. State Subject Certificate;
4. Income Certificate in respect of Poor & Backward Candidates and
5. Any other Certificate demanded by the College Authorities.

The colleges shall keep Admission Counters open even on holidays / off days and designate nodal officers to facilitate the candidates in the process of admission. The colleges shall also forward the shortfall, if any, on the same day up to 5.00 P.M.

The following seats have remained unfilled as on 07-09-2017:

1. JIAR Jammu : 11 OM and 3 P&B seats of BAMS
2. JCP Jammu : 16 OM and 4 P&B seats of BPT

Further, the next round of counselling for upgradation/allotment of the above seats as well as seats falling vacant due to non-joining of candidates who have already been allotted discipline/institution shall take place on 20th of September, 2017. Candidates up to * **State Rank 8000**, if interested, are directed to report BOPEE office Srinagar/Jammu, along with necessary documents, from 09:00 A.M. to 10:00 A.M. for registration, verification of documents and payment of counselling fee etc and to participate in the counselling for allotment of a seat. The Seat Matrix shall change on minute to minute basis depending upon allotment / upgradation of the seats, which shall be displayed on the monitors available in the BOPEE. The seats shall be allotted at a particular point of time on the basis of merit cum preference of the candidate available within the counselling centre. Candidate even with a higher merit who has missed the counselling shall have no claim on a seat which could have been allotted to him/her had he/she been present in the BOPEE office/counselling centre at his/her turn of counselling but for his/her absence.
