Notification No. 119-BOPEE of 2017 Dated 15-09-2017

Whereas, the Ministry of AYUSH vide their communication dated 14-09-2017 has extended the cut off date for admission in UG/PG Courses in AYUSH Colleges for the academic session 2017-18 upto 31st October, 2017 instead of 30th September, 2017.

Now, therefore:-

1. In partial modification of Notification No. 111-BOPEE of 2017 dated 06-09-2017, the last date for submission of documents for admission to PG Course in AYUSH 2017-18 is hereby extended and shall now be upto 3rd October, 2017;
2. The candidates who have appeared in the examination conducted by AIA-PGET and whose result has been declared and wish to participate in the counselling for admission to PG courses in AYUSH may deposit their documents/check list along with preference forms and a fee of Rs.1500/- in the BOPEE office, Jammu/Srinagar upto the aforementioned date;
3. Such candidates who have deposited the documents but have not deposited the counselling fee so far shall also deposit the counselling fee of Rs.1500/- in the BOPEE office Srinagar/Jammu through POS machines as notified earlier;
4. The date of completion of rotatory internship for determining the eligibility shall be notified separately but such candidates who are likely to complete the rotatory internship by 31st October, 2017 may on their own risk and responsibility deposit the documents in the BOPEE office but their eligibility shall be determined only after a clarification from AYUSH Ministry on the subject is obtained.

It is further notified that the counselling schedule for UG AYUSH Course shall remain the same as notified vide Notification No. 117-BOPEE of 2017 dated 12-09-2017 read with Notification No. 118-BOPEE of 2017 dated 14-09-2017.
