Notification No. 121-BOPEE of 2017 Dated 19-09-2017

Whereas, vide Notification No. 100-BOPEE of 2017 dated 18-08-2017, the counselling schedule for filling up of seats in BUMS/BAMS/BPT courses was notified and accordingly two rounds of counselling were held on 5th September, 2017 to 7th September, 2017 and 8th September to 12th September, 2017 respectively, consequent upon which provisional admission of the candidates was also notified vide Notification No. 114-BOPEE of 2017 dated 07-09-2017 and Notification No. 117-BOPEE of 2017 dated 12-09-2017; and

Whereas, Government of India, Ministry of AYUSH has vide their communication No. R.12011/41/2016-EP(IM-I) dated 15-09-2017 granted sanction to the establishment of Government AYURVEDIC College at Jammu with an intake capacity of fifty (50) seats; and

Whereas, the Principal, Government Ayurvedic Medical College, Jammu vide her letter No. GAMC/PS/66-71 dated 18-09-2017 and the State Government have notified the same to the Board vide their communication No. HD/ISM/75/2017 dated 19-09-2017 for filling up of these seats during the current session; and

Whereas, the matter has been examined and considered by the Board and it has been decided to fill up the seats in the newly created Government Ayurvedic College, Jammu, which would require a denovo exercise to give an opportunity to all candidates already selected in four Private Colleges of the State to participate in the admission process in the newly created College as well as to compete for the seats available in CRC, Bemina, more so when the last date of admission to the AYUSH courses has been extended by the Ministry of AYUSH, Government of India upto 31st October, 2017; and

Now, therefore, it is hereby notified as under:-

- i) The admissions made under Notification No. 114-BOPEE of 2017 dated 08-09-2017 and Notification No. 117-BOPEE of 2017 dated 12-09-2017 shall **stand cancelled abinitio**;
- ii) The fresh round of counselling, which shall include all seats under AYUSH Courses and CRC Bemina, shall be held on 25th and 26th September, 2017 in the Board office, Srinagar/Jammu simultaneously;
- iii) The candidates who have taken admission in the private colleges in pursuance of the earlier Notifications viz 114-BOPEE of 2017 dated 08-09-2017 and No. 117-BOPEE of

2017 dated 12-09-2017 shall be entitled to full refund of the fee deposited by them and the colleges shall release the documents and fee etc to the candidates immediately without any conditions whatsoever;

- iv) The counselling of candidates upto the State Rank of 6000 (UG NEET, 2017) shall be held on 25th September, 2017 and the counselling of candidates from State Rank 6001 to 8000 shall be held on 26th September, 2017 subject to availability of seats at BOPEE Office, Jammu/Srinagar;
- v) The counselling for seats in CRC viz DPO, DHLS, DRT & BPT shall also be held on 25th & 26th September, 2017 simultaneously along with AYUSH Courses. However, counselling for DHLS in CRC for which CET engineering candidates are also eligible, only such candidates shall be eligible for consideration who have appeared in CET 2017 and have obtained a rank upto 7252 and have not been allotted a seat/taken admission in the Engineering Courses, which concluded on 15th of August, 2017. For information of the CET candidates, the above courses are diploma courses with a duration of three years and are not comparable with the engineering degree courses in any manner. However, the NEET UG candidates, 2017 shall be eligible for DPO, DRT and BPT with the cut off rank as indicated in (iv) above i.e. 8000 State Rank;
- vi) The candidates shall be required to register a fresh in the Board Office between 09.00 a.m. to 10.30 a.m. on each day mentioned in (ii) above;
- vii) The candidates are required to fill in fresh preference forms as the earlier preference forms shall stand cancelled;
- viii) Such candidates who have not paid counselling fee of Rs.1500/- shall be required to do so by through POS machines available in the BOPEE Offices, Jammu/Srinagar for which they should carry their credit/debit cards with them. The candidates who have deposited Rs.1500/- as counselling fee should bring their receipt of payment at the time of counselling;
- ix) The candidates whose documents have not been verified shall be required to produce the documents in terms of Notification No. 100-BOPEE of 2017 dated 18-08-2017;
- x) The reservation in the Government Ayurvedic College, Jammu shall be as provided in Rule 13 of the J&K State Reservation Rules, 2005 and a revised tentative seat matrix to be operated upon consequent upon the addition of the seats of the Government Ayurvedic College, Jammu and CRC, Srinagar is annexed herewith as Annexure "A" to this Notification. The same reservation shall be applicable to CRC Courses as decided by the Board;
- xi) The candidates claiming benefit under Sports Category shall be require to approach the State Sports Council for determination of their sports points in accordance with the rules, who shall forward the same to the BOPEE latest by 23rd of September, 2017. However, in case no response is received from the Sports Council, the candidates whose

names have been forwarded by the Sports Council for consideration for admission to MBBS/BDS courses vide earlier communication notified by the Board vide Notification No. 077-BOPEE of 2017 dated 19-06-2017 shall be considered in accordance with the rules;

- xii) Other terms and conditions as applicable in Notification No. 100-BOPEE of 2017 dated 18-08-2017 shall remain the same.
