Whereas, result of the AIA-PGET, 2017 was declared by All India Institute of Ayurveda (AIIA) on 23-08-2017 consequent upon which a Notification No. 111-BOPEE of 2017 dated 06-09-2017 was issued by BOPEE wherein the candidates desirous of taking admission to MD/MS Ayurveda Course for the academic year 2017-18 in the Institute of Ayurveda and Research, Jammu were asked to submit documents/preferences/counselling fee etc in the Board office upto 12-09-2017 which date was subsequently extended to 3rd of October, 2017 in view of Ministry of AYUSH, Government of India communication No. R.11011/01/2016-EP(IM-I) dated 14-09-2017 vide which the cut off date for admission was extended upto 31st October, 2017 vide this Notification No. 119-BOPEE of 2017 Dated: 15-09-2017; and

Whereas, pursuant to the said Notifications, Board received 44 applications/counselling forms from the willing candidates for allotment of MD/MS Ayurveda seats; and

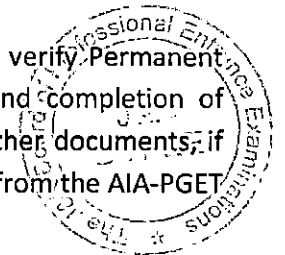
Whereas, the Board examined the preference forms submitted by the candidates and accordingly on the basis of Merit of the candidates and preferences indicated by them for the courses, prepared list of candidates to be admitted to the courses against 09 (nine) available seats in three disciplines viz MD KAYACHIKITSA, MS SHALYA-TANTRA and MD KRIYA SHARIR. The candidates who had not paid counselling fee/who expressed their desire not to be considered have been deleted from the zone of consideration.

Now therefore, on the basis of merit of the candidates & preferences submitted by them in their preference forms, list of candidates provisionally recommended for admission to MD/MS Ayurveda Courses in Jammu Institute of Ayurveda and Research, Jammu is hereby notified as per Annexure "A" to this notification.

It is further notified that:-

- The selected candidates shall report to the Principal/Director, Jammu Institute of Ayurveda & Research (JIAR), Jammu upto **13th of October, 2017** along with their relevant Certificates in Original and Score Card downloaded by them from the AIA-PGET website.
- The Principal/Director of the Institute shall check the eligibility and verify Permanent Resident Certificate, Marks Certificate, Date of Birth Certificate and completion of Rotatory Internship Certificate as per rules, in original along with other documents, if any, required and their Electronic Admit Cards downloaded by them from the AIA-PGET




- website to verify the identity of the candidates and genuineness of their certificates before actually admitting them to the course.
- iii. The Head of the Institution shall submit the Name, AIA-PGET Rank and Discipline Allotted of the candidates who have completed their admission formalities along with those who have failed to do so within the prescribed time period on **13th of October, 2017 up to 05:00 P.M.** to the BOPEE office, Jammu/Srinagar positively by fax, email and by hand also.
- iv. Only such candidates shall be eligible for admission, who have completed the mandatory rotatory internship within the cut off limit as prescribed by Ministry of AYUSH which period shall, however, be verified by the concerned Institution from the Ministry of AYUSH.

Note:-

1. The overall Merit List of MD/MS Ayurveda 2017 candidates who have submitted their documents at BOPEE office Srinagar/Jammu is available on BOPEE's website www.jakbopee.org / www.jakbopee.net and shall form Annexure "B" to this Notification.
2. Any seat remaining unfilled due to non joining etc shall be filled by the Board on the basis of the merit list already notified by the Board as per Annexure B, which shall include upgradation of the candidates as well.


