However, the candidates in waiting shall report to the Principal/Director, JIAR on **6th of November, 2017 at 2:00 P.M.** for admission in case of any shortfall. The college shall fill the shortfall from amongst the candidates in the waiting List by order of merit as given in the **Annexure "A"**.

The Head of the Institution shall submit the Name, AIA-PGET Rank and Discipline Allotted of the candidate who has completed his/her admission formalities on **6th of October, 2017 up to 04:00 P.M.** to the BOPEE office, Jammu/Srinagar positively by fax, email and by hand also.


Other Terms & Conditions shall remain the same as notified vide Notification No. 128-BOPEE of 2017 Dated: 06-10-2017.

In case any seat remaining vacant due to non-joining, withdrawal of admission etc. the same shall be filled on **7th of November 2017** from amongst the eligible available candidates in the Board premises at Srinagar/Jammu. **For the purpose of allotment of such seat(s) previous preferences shall be deemed to have been cancelled.** The allotment shall be made on the basis of merit cum fresh preferences and seat(s) available shall be offered to the available candidates in order of merit. Such candidates shall be required to join the allotted college latest by **8th of November, 2017 upto 05:00 P.M.** after which no seat shall be filled up by the concerned Institution.
