Subject: - Amendment to the information Brochure for information of MD/MS/PG Diploma and MDS 2017.

Public Notice No. 008/BOPEE of 2017

Dated: 08 - 03 - 2017

During the Joint Counselling of candidates for admission to MD/MS/PG Diploma and MDS Courses 2017 held at Jammu/Srinagar on 4th and 6th March 2017 respectively, the candidates requested that they may be allowed to compete for upgradation of the seats as may fall vacant due to non joining / resignation etc after the 1st round of the allotment of discipline/ colleges even after the submission of Status Retention Form.

Matter has been examined. Attention of the candidates is invited towards the last para of page 25 of the e- Brochure which reads as under:-

“Any up gradation or revision in the allotment of seats/colleges as may become necessary due to resultant seats caused due to non-joining/resignation etc. of a seat etc will be considered on the basis of merit cum preference only”


However, in order to clear the matter further, following clarification shall be added, to the e- Brochure below note appearing at para 22. Status Retention:-

“Clarification notwithstanding the above, any seat(s) falling vacant due to non-joining/ resignation etc of the candidate(s) shall be filled up by upgradation on the basis of (Merit-Cum) Preference only. Any candidate/all such candidates who has/have submitted the Status Retention Form and claim(s) upgradation against the said seat(s) /college(s) shall be eligible to stake a claim and the allotment of such a vacant seat shall be considered only on the basis of Merit-Cum-Preference already indicated by the candidates. The resultant seat/seats as may fall vacant consequent upon such an upgradation shall be filled up in the subsequent round(s) of counselling in accordance with information contain in the Brochure. The upgraded candidate/candidates shall be relieved by the concerned Heads of the Institutions to report to the institution allotted at a short notice, as a consequence of upgradation, who shall be required to submit a fresh Status Retention Form where allotment has been made and the earlier form shall be deemed to have been cancelled abinitio. The candidate(s) who has / have then been upgraded, shall be entitled to

refund /transfer of fee by one institution to another institution as per the procedure in vague. No further claim for upgradation shall be considered.

The details of shortfall / vacant seats at the end of first round of allotment, shall be furnished by the institutions latest by 28th of April, 2017 to the BOPEE, enabling it to notify the same for being filled up through upgradation”.
