- * The candidates who have been declared to have qualified by National Board of Examinations may furnish their comments, if they choose to do so, within a period of three days along with any documentary support which shall be examined by the Board.
- * The Rural Service seats shall be filled up strictly in accordance with MCI Regulation proviso 9(2)d read with the Hon'ble Supreme Court Judgement in the case titled Dinesh Singh Chauhan v/s State of U.P. and others.
- * The relevant extract of the MCI Regulation and the Honble Supreme Court Judgement is available on the BOPEE website.
- * The reservation for specially abled (with locomotory disability of lower limbs) shall be provided in accordance with Regulation 9(1)a of the MCI Regulations which may affect the Seat Matrix. Such candidates shall have to be examined by the designated Medical Boards
- * The eligibility for CDP, SP etc. shall be strictly as per MCI Regulations
