Subject:-NEET up gradation round/ allotment of seats under Hindu Minority Quota / NRI Quota in ASCOMS.

Notification No 093–BOPEE of 2017 Dated 12-08-2017

In continuation of Notification No. 091-BOPEE of 2017 dated 10-8-17, the shortfall reported by Government/ Private Medical/ Dental colleges is hereby notified as per annexure "A" to this notification in the form of available seat matrix. 5 unfilled seats of Diploma in Dental Hygiene as notified vide Notification No. 91-BOPEE of 2017 dated 10-08-2017 have also been included

It is further notified that:-

1. The shortfall/ unfilled seats shall be filled on 14th, 16th and 17th of August, 2017 in accordance with the details contained in Notification No 091-BOPEE of 2017 dated 10-08-2017;
2. The eligibility shall remain the same as notified vide the above notification;
3. The seats shall be filled up on the basis of merit/cum preference amongst the candidates who register themselves in accordance with conditions contained in Notification No. 091-BOPEE of 2017 dated 10-08-2017;
4. For purposes of physical allotment/Up gradation round, registered candidates shall be required to fill up the fresh preference forms and the **online preferences submitted by the candidate before 1ST counselling shall be treated as cancelled.**
5. The shortfall if any after completion of physical allotment/Up gradation round on 17-8-2017 shall be notified separately. In case the shortfall is not met with from amongst the candidates with cut off merit notified vide notification no 091, the same shall be reduced to the extent as may be deemed appropriate by the Board;
6. The unfilled seats in ASCOMS/ IDS under NRI, if any, shall be filled in accordance with rules from amongst the state subjects only, which shall also be notified accordingly. However, the NRI seats in IDS shall be filled up only after 17th of August and not during 14th to 17th of August, 2017, when the Open Merit/ Management seats shall only be filled up. The date for filing up of NRI seats in IDS shall be notified separately, considering the cut of merit as may finally emerge for OM/Management Quota seats;
7. The seat matrix shall be available on the official website of the BOPEE. The summary of vacant seats is as under:-
